

FELIX ON TRIAL BEFORE PAUL

Acts 24:22-27

The governor Felix and his wife Drusilla meet with Paul.

1. THE PURPOSE OF THE MEETING (V. 24)

- They wanted to hear of Paul's faith in Christ.
- This faith would bring about a complete change of allegiance – from faith in ourselves to faith in God!

(Acts 16:31, 20:21)

2. THE CONTENTS OF THE MEETING (V.25)

Righteousness – only God is holy and we are “unrighteous”.

- Through the cross Christ offers us His righteousness.

Self-Control - Felix and Drusilla were living in adultery.

- Through faith in Christ and the power of the Holy Spirit we can control our passions.

Judgment – All will be judged! (**Heb 9:27**)

- Christ was judged in our place!
